Planned senior Independent Schools for students aged 18-25 years, seeking Year 11 and 12 qualifications.




Disability support with options of paid employment, training and lifestyle activities for 80+ adults aged 25-55 years with a diagnosed disability in Wodonga.

Strategic ends

Indie Education is a community based, not-for-profit, educational organisation. Established in 1974 it has grown in size to support the changing educational and community needs in flexible, innovative and positive ways.

Policy and direction for the organisation is set by voluntary Directors who are (or have been) in positions of leadership with education, marketing, media, industry, commercial, legal and financial organisations. Directors are also supported by Advisory Committees made up of people with particular sector expertise.

Day to day operation of the company is the responsibility of an executive management team and capable coordinating teaching and non-teaching staff which have been drawn widely from educational and industry sectors. All have relevant experience and qualifications commensurate with their positions.

Indie Education has affiliation with the Associations of Independent Schools Victoria, NSW, Tasmania, South Australia, Western Australia and Queensland, being its recognised industry representative bodies. The company is accountable to its membership, students, parents, teaching and non-teaching staff and funding bodies at Commonwealth and State levels.

Indie Education maintains a strong focus towards diverse senior secondary school and community educational programs, which aim to reach out to the broad range of student learning needs. For over 45 years support has also been offered to particular groups in society who have traditionally been educationally disadvantaged.

The organisation holds a unique position as one of only few businesses that operate as non-government, special circumstances, registered independent schools and registered training organisation in six Australian States.

This community-based organisation currently employs approximately 400+ teaching and non-teaching staff, has an annual budget of \$45m (2022) and, has in the last decade invested over \$20m into our many school/RTO locations.
